FIRST OF ALL,I WOULD LIKE TO SOLICIT FOR YOUR UTMOST CONFIDENTIALITY AND SECONDLY,THAT YOU WILL NOT IN ANY FORM BETRAY THE CONFIDENCE THAT IS GOING TO BE REPOSED IN YOU.

I AM DR MUYIWA IGE, THE ELDEST SON OF THE ASSASSINATED MINISTER OF JUSTICE & ATTORNEY GENERAL OF THE FEDERAL REPUBLIC OF NIGERIA. CHIEF AJIBOLA JAMES IGE AT HIS RESIDENTIAL HOME IN IBADAN BY UNKNOWN ASSASSIN AT THE HOURS OF 8&9 P.M ON THE 23rd OF DECEMBER 2001. AND WITH THE SUSPECTS FACING TRIAL IN THE COURT. THE PRIME SUSPECT A FORMER DEPUTY GOVERNOR OF OSUN STATE. CHIEF IYIOLA OMISORE WAS RELEASED FROM AMONG OTHERS IN DETENTION, AND SWORN IN AS A MEMBER OF THE NATIONAL ASSEMBLY (SENATE). UNDER THE PLATFORM OF PEOPLE'S DEMOCRATIC PARTY OF NIGERIA, WHICH IS THE SAME PARTY THAT IS RULING THE FEDERAL REPUBLIC OF NIGERIA PRESENTLY LED BY PRESIDENT OLUSEGUN OBASANJO. THIS ACTION NEGATE THE CONSTITUTION OF THE LAND THAT BARRED AN EX-CONVICT OR AWAITING TRIAL FROM CONTESTING INTO ANY OF THE POLITICAL OFFICES, YET THE FEDERAL GOVERNMENT RING THE ELECTION RESULT AND SWORN IN CHIEF IYIOLA OMISORE A MURDER PRIME SUSPECT OF THE ASSASSINATION OF IT'S FIRST CHIEF SECURITY OFFICER. CHIEF AJIBOLA JAMES IGE INTO THE HOUSE OF SENATE THE HIGHEST CADRE THAT MAKES LAW FOR THE COUNTRY. AN ELECTION HE (OMISORE) NEVER CAMPAIGNED FOR INSTEAD, WAS IN DETENTION ALL THE PERIOD WITH OTHERS . CONSEQUENCE, UPON HIS FREQUENT ABSENCE FROM THE COURT HEARING. MY MOTHER JUSTICE ATINUKE IGE, COLLAPSED IN THE COURT AND LATER DIED IN THE HOSPITAL IN 2003. AND WITH CRITICISING ARISING FROM THE HUMAN RIGHTS ACTIVISTS, CHIEF IYIOLA OMISORE WAS TAKING BACK TO DETENTION. BUT SOON HE WAS DISCHARGED AND ACQUITTED FROM THE CASE ON THE 25th JUNE 2004 AND HIS COLLEAGUES CASE FILE HAS NOT EVEN BEEN OPENED UP TO THIS MOMENT TO ASCERTAIN THEIR LEVEL OF INVOLVEMENT OR NOT. THESE CLEARLY SPELT OUT THE FEDERAL GOVERNMENT INVOLVEMENT IN THE KILLING OF IT'S FIRST CHIEF SECURITY OFFICER AND THEIR ACTION AIMED AT PERVERTING JUSTICE TO THE MURDER SOUL. IN VIEW OF THE FOREGOING, THE IMMEDIATE FAMILY OF BOTH LATE MR&MRS ATINUKE BOLA IGE. MET AND RESOLVED MORE THAN EVER BEFORE THAT PART OF THE FINANCIAL ASSETS OF OUR LATE FATHER, BE MOVED/TRANSFERRED OUT OF THE COUNTRY FOR SECURITY REASON TO A FOREIGN COUNTRY WITH GOOD POLITICAL ATMOSPHERE FOR POSSIBLE INVESTMENT. THUS, I HAVE BEEN MANDATED AS A MATTER OF URGENCY TO CARRY OUT THIS ASSIGNMENT, AND TRANSFER THE SUM OF SIXTY FIVE MILLION (U.S) DOLLAR (\$65,000,000.) TO OUR CORRESPONDENTS BANK IN ITALY AND TO LOOK FOR A RELIABLE OVERSEAS PARTNER WHOM WILL HELP US RECEIVE THIS AMOUNT (\$65,000,000.) INTO HIS/HER COUNTRY ACCOUNT FOR VIABLE BUSINESS VENTURE AND WHOSE RESPONSIBILITY ALSO UPON THE RECEIPT OF THIS MONEY WILL PROCURE THE NECESSARY DOCUMENT THAT WILL ENABLE MY ENTRY INTO THE COUNTRY FOR THE BUSINESS PURPOSE, BUT NOW I AM IN ITALY TO ENABLE ME SIGN ANY DOCUMENT CONCERNING THE RELEASE OF THE FUND TO YOU UPON YOUR REPLY. AND I HAVE ALSO, BE GIVEN THE PRIVILEGE TO GRANT MY IDEAL PERCENT OF THE MONEY TO THE PARTNER FOR THE ASSISTANCE. THUS, I AM READY TO GRANT

25% ,AND THIS COULD ALSO, BE NEGOTIATED SHOULD THERE BE ANY REASON. AND MIND YOU THIS TRANSACTION WILL TAKE (14) WORKING DAYS.

IT IS UPON THIS , I AM SOLICITING YOUR ASSISTANCE TO CARRY OUT THIS PLANS THROUGH. AND PLEASE, I HAVE TO BE ASSURED THAT THIS WILL BE HANDLED WITH UTMOST CONFIDENTIALITY AND CARE, AS THE GOVERNMENT THAT HAS HAND IN THE KILLING OF MY FATHER WILL NOT HESITATE TO GET RID OF US THE MONEY IF DISCOVERED. ESPECIALLY NOW THE GOVERNMENT HAS SET UP A BODY KNOWN AS ECONOMIC AND FINANCIAL CRIME COMMISSION (EFCC) TO TRAP OUT ILLEGAL WEALTH ACQUIRED BY PUBLIC OFFICE HOLDERS AND THEIR COLLABORATORS. YOU KNOW WHAT THAT MEANS TO MY FATHER'S REPUTATION BUILD LONG WHILE ALIVE. AND I ASSURE YOU 100% RISK FREE.
